

“Restraint and Seclusion Regulation Webinar”

Program Overview:

Restraints and seclusion continue to be commonly cited and are a top concern to hospitals during surveys and complaint investigations conducted by CMS, state survey agencies and accrediting organizations such as The Joint Commission and Det Norske Veritas. This webinar will address restraint and seclusion regulations, citations and much more.

Learning Objectives:

At the completion of this webinar, participants will be able to:

- Describe CMS definitions of restraints and seclusion;
- Describe which restraint regulations are at greatest risk for citation and how to prevent a citation;
- Demonstrate requirements to utilize restraints;
- Identify which deaths while in restraints must be reported to CMS; and
- Describe the internal log requirements for restraint deaths.
