The presenter will provide a high-level 340B overview that will include split billing and contract pharmacy education. She will provide several 340B contract pharmacy best practices participants can use to implement within their healthcare facility and discuss the factors that makes claims eligible for 340B. She will share 2018 regulation updates and describe how they might affect hospitals and healthcare facilities. Finally, she will also provide strategies to help improve 340B subsidy programs.
