**Program Overview:**

This program will discuss the current CMS hospital Conditions of Participation (CoPs), including the critical access hospital, Joint Commission and DNV Healthcare standards on informed consent requirements. All hospitals that receive Medicare and Medicaid reimbursement must comply with these interpretive guidelines.

**Learning Objectives:**

At the completion of this webinar, participants will be able to:

1. Identify the 3 sections on informed consent in the CMS hospital CoP interpretive guidelines;
2. List the six minimum requirements that are now mandatory to be on the informed consent form for surgery;
3. Discuss the CMS and accreditation standards, applicable to your facility, that should be reflected in the hospital's policies and procedures; and
4. Identify the list of procedures and tests to be used by medical staff that will require informed consent under federal regulations.
